



Governor allocates \$19 million to assist students

Amid a surge of new COVID-19 cases, Governor Ducey and Superintendent of Public Instruction Kathy Hoffman announced \$19 million in funding to support schools and students who are most impacted by the COVID-19 pandemic.

The funding, provided by the Governor's Emergency Education Relief (GEER) Fund to support help students not fall behind by using the Acceleration Academies Grant Program.

The program is administered by the Arizona Department of Education (ADE). Eligibility is determined through a partnership with Read On Arizona and the Maricopa Association of Governments. These organizations consider AZMerit scores, percentage of students eligible for free and reduced-priced meals, access to computers and internet, COVID-19 cases in the community and unemployment claims. Eligible schools can choose the best fit for their needs such as:

- Training teachers in best practices for math and literacy instruction;
- Teacher stipends for additional student tutoring sessions;
- Contracting with qualified math or reading specialists to do one-on-one or small group work with students;
- Operating summer math or reading intensive programs.

AZDHS Issues COVID-19 Update

Governor Ducey urged residents statewide to remain vigilant and use precaution amid a surge of new COVID-19 cases. Arizona Department of Health Services (AZDHS) officials reported more than 3,000 COVID-19 cases in a single day, the most since July 15th. For November, the state is averaging nearly twice as many new cases daily than October and the highest daily average since July. Arizona is also averaging the most daily deaths since August.

AZDHS figures show that 88% of inpatient beds and 86% of ICU beds were in use, which includes people being treated for COVID-19 and other patients. COVID-19 patients were using 16% of all inpatient beds and 20% of ICU beds. Overall, 33% of ventilators were in use. The state's COVID-19 rate of spread (Rt) is above 1 at 1.13 (the average number of people a COVID-positive individual will infect). Of known test results from last week, AZDHS reported that 9% have come back positive. A positivity rate of 5% or less is considered a good indicator that the spread is being controlled.

Governor extends Executive Order for reporting COVID-19 data

Governor Ducey issued an executive order that extends the Enhanced Surveillance Advisory for 60 days amid a surge of new COVID-19 cases and increased testing positivity.

Issued in March, the advisory requires hospitals and other facilities to report daily statistics on staff resources, ventilator availability, intensive care unit bed availability, inpatient bed availability and levels of personal protective equipment and medical supplies; testing laboratories must report results of all COVID-19 tests. According to the Governor, the continued flow of data will provide Arizona Department of Health Services (AZDHS) "with the real-time information they need to make informed decisions and allocate critical resources while keeping the public informed."

President Fann requests independent review of election

Senate President Karen Fann (LD1) sent a letter to Arizona Secretary of State (AZSOS) Katie Hobbs seeking an independent analysis of the testing of Arizona voting machines.

President Fann explained that raising concerns and having an independent analysis performed would assure those suspicions of fraud and prevent them from lingering and which could cause substantial damage to the trust in our election results. President Fann requested that Secretary Hobbs make the data available to an independent expert for evaluation and to expand the hand count audit in Maricopa County to five percent of the voting center locations, up from two percent. President Fann wrote, "assuming the allegations of fraud are without merit, an independent analysis would help to restore credibility.".

Secretary Hobbs responded that the election was a success. She wrote "to be clear, there is no 'current controversy' regarding elections in Arizona, outside of theories floated by those seeking to undermine our democratic process for political gain.". She continued, "it is patently unreasonable to suggest that, despite there being zero credible evidence of any impropriety or widespread irregularities, election officials nonetheless have a responsibility to prove a negative.". Secretary Hobbs declined President Fann's request and indicated that launching an independent review with taxpayer dollars could jeopardize the orderly completion of the election.

President Fann believes that her request is reasonable. She stated, "if there's no factual basis on any of these things, then absolutely, let's put that to rest and show them that's not true.". She continued, "If there's something there that needs to be fixed, let's fix it.".

The Senate Democrat caucus elected Senator Rebecca Rios (LD27) as Senate Minority Leader. Senator Lupé Contreras (LD19) was re-elected as Assistant Senate Democrat Leader and Senators Martín Quézada (LD29) and Victoria Steele (LD9) were elected as Co-Minority Whips.

Last session, a top legislative priority for Representative Engel was to repeal legislation that blocked counties and municipalities from requiring an owner, operator or tenant of a business, commercial building or multifamily housing property to measure and report energy usage and consumption.
